

## **Statement to Gardai relating to**

### **(a) The crimes of manslaughter and medical malpractice and malfeasance**

### **(b) The crimes of Threats with Menaces and Extortion and Blackmail**

There is a legal requirement and legal duty of people to report a crime to the gardai if one is aware that a crime has been committed. I am aware that some serious crimes have been committed and need to be investigated and prosecuted. I am reporting these to the gardai. It concerns the crime of manslaughter and malpractice and malfeasance by a medical doctor who gave a vaccine to a person and HSE officials who approved it. On August 4<sup>th</sup> 2021 the Janssen vaccine was officially withdrawn from the Irish market due to concerns about blood clotting and haemorrhages and deaths from this vaccine. On Friday August 13<sup>th</sup> 2021 Roy Butler received the Janssen vaccine from his doctor in Waterford which was nine days after the vaccine was officially withdrawn from the Irish market. Roy Butler became very ill within a few hours of receiving the vaccine. He got bad headaches and vomiting and fits that Friday and for the weekend. He was admitted to hospital that weekend and he died of a bleed on the brain on Tuesday 17<sup>th</sup> August. Prior to the getting the vaccine Roy Butler was a very healthy person and sportsman and had no previous history of internal bleeding or brain illnesses. It was well known by scientists and medical doctors and HSE and government officials that the Janssen vaccine caused haemorrhages in the body including bleeds on the brain and also blood clots and other blood disorders and neurological illnesses which can lead to death or serious disabilities yet this vaccine continued to be illegally administered after August 4<sup>th</sup> 2021 in Ireland.

Post mortems of dead vaccinated people have confirmed spike protein can accumulate in many areas of the body causing damage including clots and haemorrhages (bleeds). We are encouraging the Irish authorities to carry out autopsies of dead covid vaccinated people to establish exactly how the vaccines killed them and to not cover up these deaths and crimes. Cover ups of crimes have got to end in Ireland.

It has come to our attention that the HSE hospitals and medical doctors and pharmacies continued to administer the Janssen vaccine after August 4<sup>th</sup> in full knowledge that this posed a threat to life and could kill people and also they were illegally back-dating the vaccine to dates prior to August 4<sup>th</sup> 2021. The covid19 vaccines have presented an opportunity to make vast profits. The desire of HSE hospitals and medical doctors and pharmacies to make money and profits has taken precedence over human life to the extent that they will place lives in danger and even kill people to make money. This amounts to medical malpractice and the administration of poisons and malfeasance (by public officials) leading to the manslaughter of Roy Butler. It is also a fact that those people receiving the vaccine are not giving their informed consent as they are not being told about the risks and dangers of the covid19 vaccine. Many of these risks and dangers are outlined on the web site [www.data-analytica.org/page2.htm](https://www.data-analytica.org/page2.htm) . It is illegal not to get informed consent. These crimes are serious. They will require thorough investigation and prosecution. I ask the gardai to make use of the whistleblower acts and witness protection laws to protect whistleblowers in the HSE and medical doctors practises and pharmacies. There is evidence of revenge and blackmail and extortion being used against all persons who are speaking out.

Other similar deaths of young vaccinated people from the vaccines will over time be brought to the attention of gardai so that these crimes can be exposed and prosecuted in the courts. The second criminal charge relates to an email which was sent out to HSE staff including those in agency work for the HSE on August 6<sup>th</sup> 2021. The staff were threatened to get the covid19 vaccine or lose their jobs and have their wages stopped. I attach the email which was sent out. This amounts to threats with menaces and to blackmail and extortion. It should be noted that the HSE has financially benefitted from its association with vaccine companies in the past and present and that there are financial inducements for the HSE and medical doctors to encourage uptake of the covid vaccines among the general public. These financial inducements or bribes may be fuelling the threats with menaces and blackmail and extortion against HSE and agency staff.

The issue of informed consent is also relevant here. It is a fact that those people receiving the vaccine are not giving their informed consent as they are not being told about the risks and dangers of the covid19 vaccine. Many of these risks and dangers are outlined on the web site [www.data-analytica.org/page2.htm](https://www.data-analytica.org/page2.htm) . It is illegal not to get informed consent. Indeed forcing HSE or its agency staff to get experimental vaccines which carry significant risks of death or injuries and

disabilities is illegal. These criminal charges may be added to the existing charges of threats with menaces and blackmail and extortion.

I ask the gardai to make use of the whistleblower acts and witness protection laws to protect whistleblowers in the HSE and it's agency staff. There is evidence of revenge and blackmail and extortion being used against all persons who are speaking out.

Dear All Health Care staff,

This is a follow up from my previous emails regarding the HSE Public Health findings. They found that agency staff could pose a risk of spreading COVID-19 if they are unvaccinated due to the fact that they go to various locations and could be members of numerous agencies and are therefore uncontrolled.

The HSE and all the Hospitals groups are now insisting that the COVID 19 vaccine must be added immediately to the list of required vaccines for Agency staff. The reason is the same for all vaccines..... to protect the agency Health Care staff themselves, their patients and their colleagues. It is unfortunate that this includes people with medical conditions that can't be vaccinated. We will do our best to find work that doesn't involve patients like help lines etc but these jobs are rare enough as the HSE have already given them to their own directly hired staff who can't get vaccinated.

Nurse on Call are adhering to the HSE and Hospital Groups request and will not place staff who are unvaccinated going forward. We also require a copy of either your vaccination card or your EU Digital COVID passport.

We do not have a copy of these documents for quite a few staff who are directly booked so could those of you who are outstanding these documents please send them to [bookings@nurseoncall.ie](mailto:bookings@nurseoncall.ie) straight away or [corkoffice@nurseoncall.ie](mailto:corkoffice@nurseoncall.ie) if in the south.


From Monday 16/08/2021, I have instructed the accounts department that we will no longer be paying anyone who is unvaccinated or those whom we do not hold proof of vaccination for, as we no longer have the authority to do so. Any Health care staff who are being booked directly and are not vaccinated, will not be covered by the HSE and the Hospitals groups and those that book you no longer have the authority to do so. Please do not send us time sheets for any dates worked after that date as they will not be paid if you are not vaccinated.

We will accept a copy of the first vaccination as long as it's clearly indicated when the second shot is due and you agree to all the usual HSE guidelines, that you remain masked at all times, stay in one location only and take breaks on your own, (in order to remove your mask).

Please don't shoot the messenger either as accounts will only be doing their job.


