

## STATEMENT OF BG AND DE to Gardai

There is a legal duty to provide accurate and truthful statistics, and to take extra measures to ensure statistics are accurate, especially during pandemics, epidemics, Winter flu seasons and post pandemics / epidemics. This relates specifically to False Statistics and Misleading Statistics provided by the accused in relation to the following:

- the accurate number of covid19 cases and deaths in 2020 and 2021.
- total number of deaths mislabelled as 'covid19'. The attached Book of Evidence and existing statistics since Summer 2020 show that 94% of alleged covid19 deaths had two or more pre-existing illnesses or conditions and that the False Positive rate for covid19 for Ireland is approximately 97%. And there is reason to believe that some death certificates were falsified to state 'covid19' as the cause of death. Labelling deaths from cancers, heart diseases, respiratory diseases, neurological diseases, endocrine diseases, dementia diseases, accidents, diabetes as covid19 undermined the integrity of Statistics for deaths, mortality and excess mortality in Ireland. This is important given the fact that the average of death from covid19 was 82 and the median age of death was 84 which is slightly higher than Irish life expectancy.
- the total number of False Positive covid19 cases and deaths in Ireland
- the percentage of covid19 cases and deaths which were False Positives.
- the alleged covid19 deaths minus the False Positives and those people who had pre-existing illnesses and died with covid19 but not specifically of it for year 2020 and 2021 and for flu season 2020 and 2021.
- the cycle counts for PCR tests for covid19 and the rate of False Positives for covid19 in Ireland. International statistics and scientific findings stating the relationship between PCR cycle counts and False Positives
- the rate of False Positives among asymptomatics
- the Infection Fatality Rate (IFR) for covid19
- the false statistics for covid19 deaths by merging the flu season of 2020 with the flu season of 2021 to over-inflate the deaths from covid19. These were separate flu seasons. Every year for the last 50 years, deaths in a flu season for one year were counted separately to the flu season of other years. This procedure should be followed in 2020 and 2021 by state bodies and the government.
- the mortality figures and excess mortality figures for flu season 2020 and flu season 2021
- the mortality figures and excess mortality figures for the year 2020 and separately for the year 2021
- **Mortality and Pandemic Issues**

According to the General Registration Office and evidence in the attached affidavit, the mortality and excess mortality for June to December in 2020 was less than in previous years on a monthly basis

and a 7 monthly basis. If there was a pandemic during this time the mortality and excess mortality for this period would be significantly higher than previous years. The evidence here shows that the covid19 pandemic ended in June 2020. The flu and colds season began in December 2020 and continued on until March 2021. In some years the flu season extends out to April and the bulk of cases and deaths shift out to April. This is primarily concentrated in the elderly and more vulnerable section of the population. This is in line with colds and flu seasons in Ireland for hundreds of years. Mislabeling a virus or a bacteria or any other illness as 'covid19' or 'covid21' or any other name through defective PCR tests which give over 90% False Positives does not change these facts.

- the statistics and numbers provided by Mr. Kieran Morrissey and RIP.ie and presented in the Book of Evidence directly contradict the statistics of the CSO, NPHET, the CMO, and McCarron and McCarthy on RTE television on April 20<sup>th</sup> 2021. - The number of confirmed flu and colds and (bacterial and viral) pneumonia cases versus the number of confirmed covid19 cases minus the False Positives for covid19 in Winter season 2020 and Winter season 2021. Confirmed means the use of samples and cultures and the isolation and purification of pathogens and the identification of their genome.
- number of deaths from covid19 vaccines in Ireland. The covid19 vaccines were rolled out in mid January 2021.
- excess mortality figures after covid19 vaccinations began in mid January 2021.
- the name of the national tracking system used to identify vaccine deaths and injuries and new illnesses, and its accuracy and effectiveness and the statistical methods and analysis used. And how this informs the CSO and General Registration Office and HSE and Government.
- number of covid19 vaccine deaths mislabelled as 'covid19' in nursing homes and throughout society
- excess mortality figures for nursing homes after covid19 vaccinations began in January 2021
- mortality figures and injury figures for these persons under 20 and under 30 from effects of covid19 vaccines. These age groups have a very tiny and almost zero chance of dying of covid19.
- hospitalisations for injuries and illnesses caused by the covid19 vaccine
- official government bodies are reporting deaths and injuries and new illnesses caused by covid19 vaccines, see [www.data-analytica.org/page2.htm](http://www.data-analytica.org/page2.htm) .

What are the total injuries and new illnesses and deaths caused by covid19 vaccines in Ireland for 2021 and subsequent years.

- the government measures in place in 2020 and 2021 to track deaths, injuries and illnesses caused by vaccines so as to provide accurate statistics
- the number of suicides in Ireland in 2020 and 2021 and the excess mortality from suicides caused by the lockdowns.
- the increase in the number of addicted people caused by lockdowns

- wearing masks over long periods of time can result in causing pulmonary fibrosis, a dangerous and often fatal disease according to a court case being heard in Britain, see <https://www.crowdjustice.com/case/stop-masks-in-schools/> . Numbers of persons who got pulmonary fibrosis and other health conditions and illnesses from wearing masks in Ireland in 2020, 2021, 2022 and for subsequent years.
- there are allegations and statistics claiming that the flu's and colds disappeared in Winter 2020 and Spring 2021. Were these allegations and statistics confirmed by PCR tests and cultures and isolation of pathogens and identification of their genomes ? or were all flu's and colds cases classified as covid19 or were they part of the False Positives for covid19 ?
- the number of non covid19 deaths caused by the cancellation of over 200,000 hospital appointments in 2020 and 2021 due to Lockdowns. And the relationship of this to mortality and excess mortality figures in 2021 and subsequent years. And care must be taken not to mislabel these as covid19 deaths again.

There are concerns over false statistics and concealment of statistics and related evidence by the accused and agents under their control including the CSO and RTE. Both of these and the accused may have a case

to answer in court for the provision of false statistics and misleading statistics. The provision of false statistics about covid19 on the Prime Time show on RTE television on April 20<sup>th</sup> 2021 by so called "experts" McCarthy and McCarron also comes within this remit as it influenced the general public, the government and their advisors and had an agenda of pushing for zero covid which is unscientific and anti-medical and impractical but which would impose more lockdowns and massive losses on the businesses workers and people of Ireland.
