Blocking of use of Ivermectin

Dear Mr Donnelly;

It is now quite clear that there is a worrying and somewhat sinister attempt to block the use of Ivermectin in the prevention or treatment of SARS-CoV2 infections. This despite numerous randomised control trials, observational trials and case studies. The arguments against use include lack of evidence, clearly this isn't the case and the safety profile. This drug is 50 years old and has resulted in approximately 20 deaths in that time. Aspirin has killed multiples of this number.

Given that much of the evidence has been in existence for at least one year, and more has subsequently emerged, I would assert that the writers of the ICGP guidelines (April 2020) and the subsequent HIQA guidelines (January 2021) are guilty of the crime of wilful blindness as defined: "The doctrine of willful blindness imputes knowledge to an accused whose suspicion is aroused to the point where he or she sees the need for further inquiries, but deliberately chooses not to make those inquiries."

As are those who were party to sanctioning such documents. The instructions in these documents

advised GPs to basically do nothing in the initial phases, except perhaps have a PCR test to confirm infection, most were not seen by their family doctors, and if they worsened were sent to hospital.

Sadly, many of those in nursing homes were not offered a hospital admission, instead were given oxygen, morphine and midazolam whilst awaiting death.

In all these cases a window of opportunity in the early stages of this condition was lost.

No doubt some of these people would have worsened and died anyway but we will never know how many could have survived because, in the main, GPs did nothing.

Massive Increase in Covid19 Vaccine Deaths in USA in July 2021. Federal court case about this is proceeding in the USA. More Corroboration of our Evidence and Findings in Ireland in the Federal Court papers filed in the USA.

In July 2021, an American lawyer Thomas Renz filed papers with a federal court in Alabama in USA stating that 45,000 people died within 3 days of taking the covid19 vaccine and he has a whistleblower and a sworn affidavit attesting to this. This is initiating FBI and law enforcement investigations and federal court hearings for later this year. These 45,000 vaccine deaths are just one government reporting system. There are several other government reporting systems tracking vaccine deaths and there could be thousands more in each of these reporting systems. Absolute Reduction Risk (ARR) of covid19 vaccines

Absolute Reduction Risk (ARR) measures the vaccine effectiveness against covid19. According to a study published by the NIH, the ARR for the Pfizer Vaccine is a mere 0.7%, and the ARR for the Moderna Vaccine is only 1.1%. This is very tiny and provides very little or no protection. The covid19 vaccines provide no real benefit or protection from covid19 but the vaccines pose moderate to high risks of vaccine injuries, illnesses and death. For children and young adults these risks are high when compared to the risk from covid19. Imposing vaccine passports on everybody for this is a fraud and a crime.

Increase in Hospital admissions, injuries, new illnesses and deaths in 2021 caused by covid19 vaccines. Covid19 vaccine injuries and deaths are being classified as 'new variants' of covid19 and this may be used to enforce more lockdowns in 2021 and 2022

There is evidence of increased hospital admissions in Ireland and Britain among those who were vaccinated with covid19 vaccines since late January 2021. There are correlations between the covid19 vaccines and the spread of new variants of covid19 in countries around the world and this evidence was supplied in the previous Supplementary Evidence submitted to the police in Ireland and is also available on www.data-analytics.org/evidence.htm and on www.data-analytica.org/page2.htm

The so called "variants" are the result of defective PCR tests with a high rate of False Positives as high as 97% in Ireland and other countries using cycle counts of 35 to 45.

The deaths and injuries and hospitalizations from the covid19 vaccines need to be more carefully monitored and tracked in Ireland.

- Every person hospitalized within 20 months of getting the covid19 vaccines should be investigated and monitored for covid19 vaccine injuries / illness / disability caused by the covid19 vaccine. Long term tracking and studies should extend for 5 - 10 years after vaccination for scientific and medical reasons.
- Every person who dies within 20 months of getting the covid19 vaccines should be investigated and monitored for covid19 vaccine caused death. Long term tracking and studies should extend from 5 – 10 years for scientific and medical reasons. **Autopsies of dead covid19 vaccinated people must be made mandatory under law.**
- Every person who attends a medical doctors clinic for serious illnesses or new disability within 20 months of getting the covid19 vaccines should be investigated and monitored for covid19 vaccine injuries / illness / disability caused by the covid19 vaccine. Long term tracking and studies should extend for 5 - 10 years after vaccination for scientific and medical reasons.
- How many covid19 vaccine deaths and injuries and disabilities are being mislabeled as covid19 or covid19 variants ? The mislabeling of covid19 vaccine deaths and injuries and disabilities as covid19 or variants of covid19 can be used to keep this 'pandemic' going indefinitely for more years and enforce more lookdowns.
- The main causes of covid19 vaccine injuries, disabilities and deaths are
 - (a) the spike proteins in the organs and blood vessels of the body and the complications, clotting, hemorrhages, new diseases and inflammatory damage they cause including significant damage to the nervous system and vascular system and reproductive system
 - (b) the Antibody-dependent enhancement (ADE) that this vaccine causes. Scientific trials of similar

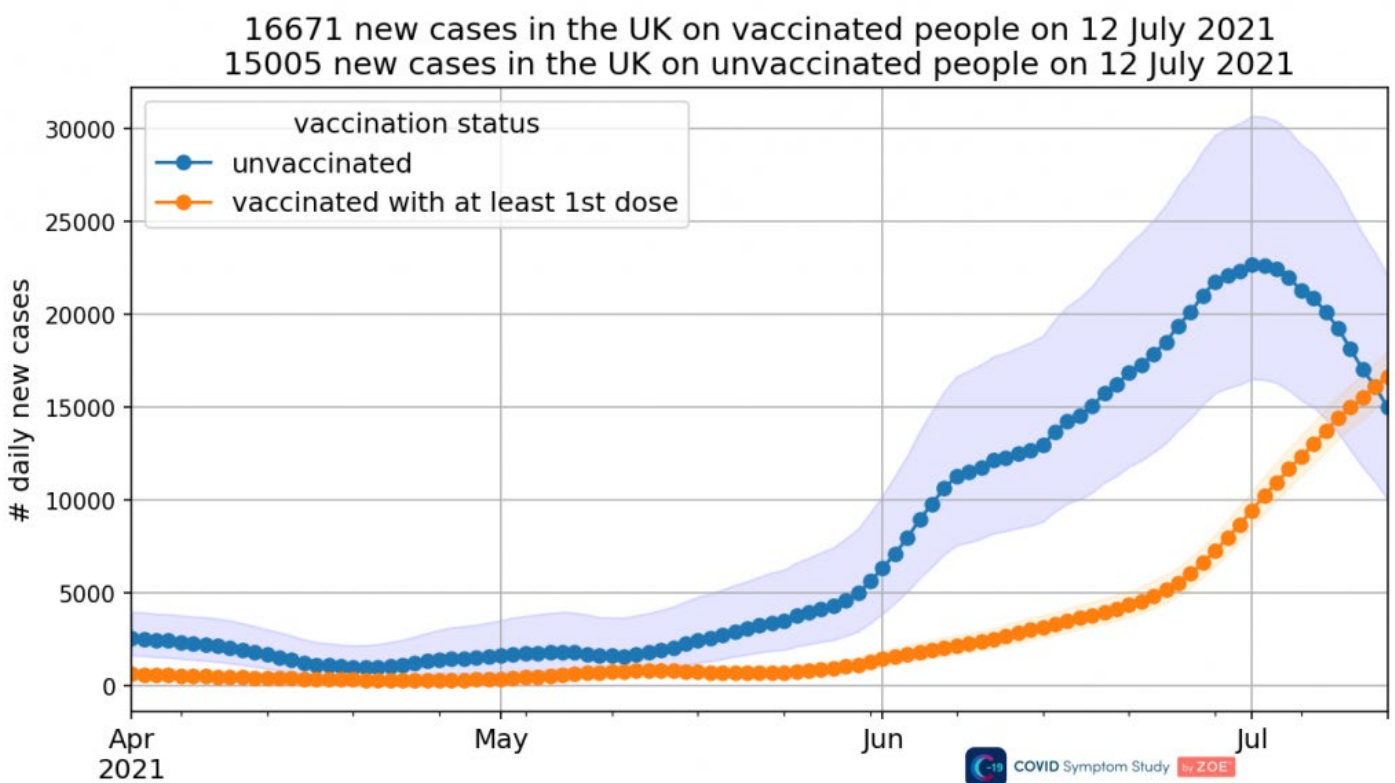
vaccines in the past for SARS 1 (covid19 is SARS 2) showed that Antibody Dependent Enhancement (ADE) led to high death rates among animals when exposed to wild forms of SARS. The same risks of Antibody Dependent Enhancement (ADE) and deaths / serious injuries apply to the present covid19 vaccines especially in Winter and Spring. ADE is believed by top scientists to be playing a significant role in the generation of new variants of covid19.

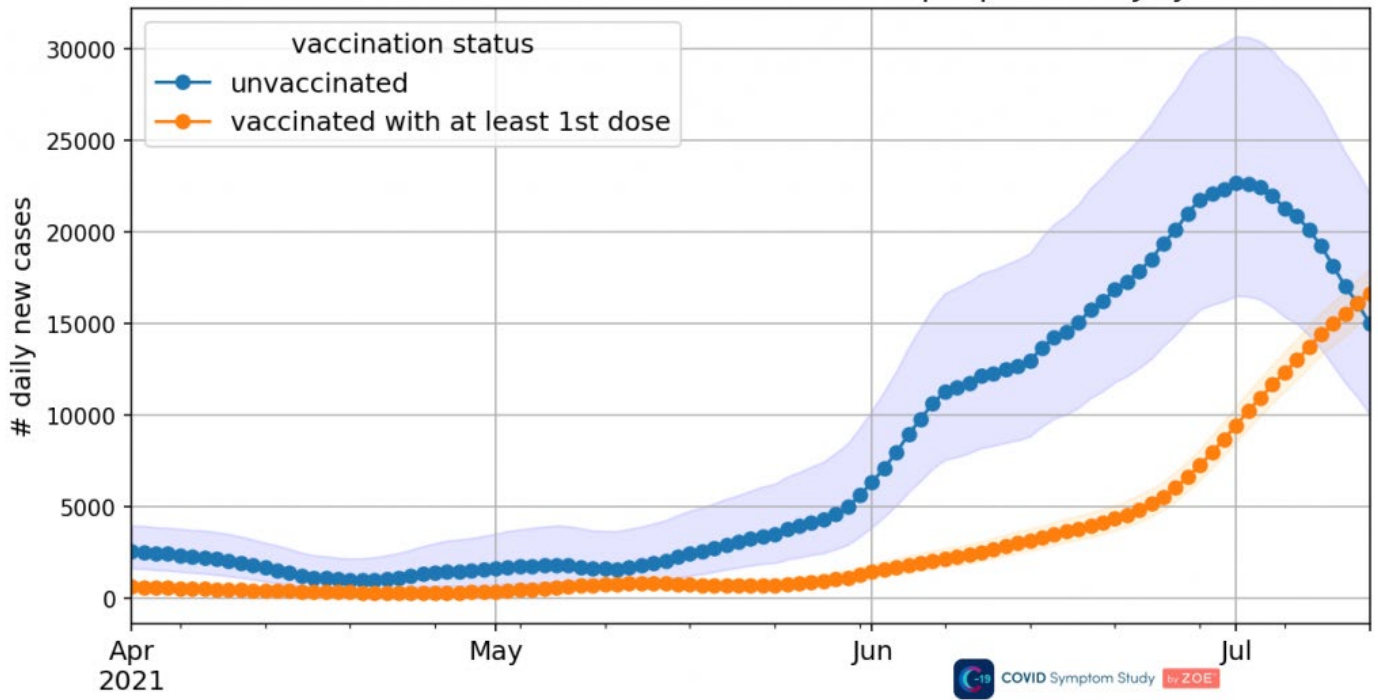

Using vaccine passports for experimental, mostly ineffective and unsafe covid19 vaccines to discriminate against people in the provision of goods and services is discriminatory and is breach of existing laws and the Constitution including :

- the Equal Status Acts
- the Irish Constitution
- EU Charter of Fundamental Rights
- the Nuremburg Code
- EU and UN Human Rights
- GDPR
- Council of Europe Resolution 2361 of 2021
- important court precedents such as GLADYS RYAN v. THE ATTORNEY GENERAL.

The new law creates a system of apartheid and it can and will be challenged in the courts. There will also be criminal court cases to address the breaches of important rights and the criminalization of innocent people and the resulting deaths and injuries from HSE and government policies detailed in this paper.

Secondly the Irish Government and HSE have no means of determining who has recovered from covid19 as the scientific literature and published scientific research shows that there was pre-existing immunity to coronaviruses and covid19 prior to March 2020, that is both normal antibody immunity and T cell immunity, and many people as much as 30% of the population got covid19 infections and recovered without experiencing symptoms or realising that they had it. The Government's legislation would discriminate against persons who recovered from covid19 as they had pre-existing immunity to it. But no certificates or passports to prove their pre-existing immunity. Yet the new law claims to be doing the opposite – allowing recovered people to access indoor dining and pubs and foreign travel. This creates a serious contradiction in the law and would bring the law into disrepute. The judges and courts will not support this legislation on these grounds. Courts will strike down this law.

High numbers of “Breakthrough infections” of covid vaccinated people in Ireland and abroad means the covid19 vaccines are ineffective. Though there are concerns among scientists and doctors that many of these “Breakthrough infections” may be covid vaccine injuries, illnesses and deaths mislabeled as covid19 through defective PCR tests.

This has created frauds which will be tested in the Irish courts and international courts.



According to Science and top scientists, the main causes of covid19 vaccine injuries, disabilities and deaths are:

Infection Fatality Rate (IFR)

Dr. John Ioannidis a Professor of Medicine and Statistics at Stanford University and one of the top Epidemiologists in the world has published the following scientific research which shows that covid19 has the same mortality as flu seasons in the past.

' Findings: I included 61 studies (74 estimates) and eight preliminary national estimates. Seroprevalence estimates ranged from 0.02% to 53.40%. Infection fatality rates ranged from 0.00% to 1.63%, corrected

values from 0.00% to 1.54%. Across 51 locations, the median COVID-19 infection fatality rate was 0.27% (corrected 0.23%): the rate was 0.09% in locations with COVID-19 population mortality rates less than the global average (< 118 deaths/million), 0.20% in locations with 118-500 COVID-19 deaths/million people and 0.57% in locations with > 500 COVID-19 deaths/million people. In people younger than 70 years, infection fatality rates ranged from 0.00% to 0.31% with crude and corrected medians of 0.05% .’

PCR Tests for covid19

- The CDC and FDA will be withdrawing their support for the PCR test for covid19 from December 31st 2021. Such assays can facilitate continued testing for both influenza and SARS-CoV-2 and can save both time and resources as we head into influenza season. Laboratories and testing sites should validate and verify their selected assay within their facility before beginning clinical testing.

- A recent News report in USA stated the following:

'the "casedemic" is the elevated number of cases we see nationwide because of a flaw in the PCR test. The number of times the sample is amplified, also called the cycle threshold (Ct), is too high. It identifies people who do not have a viral load capable of making them ill or transmitting the disease to someone else as positive for COVID-19.

The [New York Times](#) reported this flaw on August 29 and said that in the samples they reviewed from three states where labs use a Ct of 37-40, up to 90% of tests are essentially false positives. The experts in that article said a Ct of around 30 would be more appropriate for indicating that someone could be contagious - those for whom contact tracing would make sense.

Just a few days earlier, the CDC had updated its guidelines to discourage testing for asymptomatic individuals. It can only be assumed that the rationale for this was that some honest bureaucrat figured out the testing was needlessly sensitive. He or she has probably been demoted.

This change was preceded by a July update that discouraged retesting for recovered patients. The rationale for the update was that viral debris could be detected using the PCR test for 90 days after recovery. The same would be true for some period of time if an individual had an effective immune response and never got sick. Existing immunity from exposure to other coronaviruses has been well documented. These are many of your "asymptomatic" cases.

However, due to political pressure and corporate media tantrums, the new guidance on testing was scrapped, and testing for asymptomatic individuals is now recommended again. Doctors do not receive the Ct information from the labs to make a diagnostic judgment. Neither the CDC nor the FDA has put out guidelines for an accurate Ct to diagnose a contagious illness accurately.

Hence, our current "casedemic." Positive tests as they are counted today do not indicate a "case" of anything. They indicate that viral RNA was found in a nasal swab. It may be enough to make you sick, but according to the *New York Times* and their experts, probably won't. And certainly not sufficient replication of the virus to make anyone else sick. Criminal Intent

Criminal Intent always involves personal enrichment and/or group enrichment through illegal or unlawful or unjust means which cause losses and/or harms to another person or persons. In law, fraud is often the first step in the committing of crime and this provides the means for further criminal activities to ensure personal or group enrichment. A fraud which creates mass fear and panic while pretending to offer a solution is the perfect instrument of fraud and crime. It hides the fraud behind false perceptions of “good intentions”, the “common good” and “the public interest”. Fraud and lies and deception which cause a misuse of the state’s resources and the state’s power to enforce a certain outcome involving the acquisition of massive profits and/or pay offs for certain parties provides Intent, Motive and Opportunity - the ingredients of crime. And there is the reassurance that the state will protect its own state criminals and allow crimes and frauds to go uninvestigated and unprosecuted and unpunished.

The criminal intent involves:

- The use of a fraudulent PCR test with high cycle counts (35 to 45) to create false positives for covid19 as high as 97% and false statistics and create massive public fear and panic. The scientists and doctors and government advisors knew about the high Rate of False Positives for covid19 by October 2020 but they persisted in supporting and enforcing this PCR test with it’s high rate of False Positives for covid19. It was a Pandemic of False Positives. And the government and its advisors including NPHET cynically used the press and media to inflame this panic and fear of covid19. This was used to create mass fear, panic and paranoia in the general public so as to get public support for lockdowns and to introduce lockdowns and to profiteer from this as detailed in our reports. Hitler used similar fear tactics to pass the Enabling act in 1933 under the guise of “protecting the public” and this was used to create a “New Normal” or “Re-set” involving dictatorship and fascism. These same tendencies still exist today.

Why would people wish to create fraudulent PCR tests with high rates of False Positives and create mass panic and fear and oppressive lockdowns which destroy the economy and society ? The answer is obvious – massive profits and personal enrichment and/or group enrichment. Crime is always done for financial gains and other advantages. In law, fraud is often the first step in the committing of the crime and this provides the means for further criminal activities to ensure personal or group enrichment. In law, fraud vitiates everything. This means all policies, laws and measures which proceed from fraud can be struck down in court and declared null and void.

- Several studies show that 90% - 95% of the people who died from covid19 in 2020 had 2 – 3 serious illnesses which could have killed them and most were elderly and the average of death from covid19 in Ireland was 82 and the median age was 84. This was the same in most other countries. And our evidence shows that healthcare systems mislabeled many deaths as covid19 and there were financial incentives to do so. This enhanced and worsened the covid19 fraud.
- Lockdowns which are the deliberate shutting down of economies and societies lasting over 12 months were calculated to create mass desperation and fear and this was used to force the sale of PPE and experimental, untested and dangerous covid19 vaccines for massive profits. The intent is to continue these covid19 vaccines into the future by promoting more booster shots and more public fear of alleged “variants” of covid19 accompanied by dependency on vaccine passports and vaccine shots all of which will be followed by fears of new viruses and new strains of viruses which may also emerge from labs in the future thus providing massive profits for vaccine makers over an extended period of time. The motivation and intent is massive profits on a global scale.

If the intent and motivation was to save lives from covid19 in 2020 and 2021 then why did the government and medical authorities block and ban several effective cheap and safe medicines for covid19 in 2020 and 2021 ? The government and NPHET knew these medicines were safe and effective in 2020 and 2021. There are many published scientific studies and papers and also clinical studies by doctors verifying that these medicines work. The government and NPHET had been supplied with the Great Barrington Declaration authored by top scientists and doctors in October 2020 which called for Focussed Protection but they ignored this and refused to implement it. And why did the government and NPHET deny and lie about pre-existing immunity to coronaviruses including covid19 among most of the population when this was already known by November 2020.

The legal term “Qui Bono” applies here. Who benefits financially from this ? Why go to such extreme measures as lockdowns of a whole country for over 12 months when effective medicines are already in place since March 2020 and the Infection Fatality rate was known to be 0.23% then and comparable to a flu season ? in Spring 2021 the Infection Fatality rate was known to be 0.15% but the governments continued with lockdowns into Summer 2021. These were very extreme measures

by politicians for something which was equivalent to a flu season which we have had for hundreds of years. We never locked down countries for colds and flu's in the past.

- The FDA and US government knew about the high risk of deaths and serious injuries and disabilities from these covid19 vaccines prior to giving them emergency authorization in December 2020. The European authorities (EMA) and Irish authorities knew about the high risk of deaths and serious injuries and disabilities from these covid19 vaccines prior to giving them emergency authorization in January 2021. And these governments and authorities in North America and Europe including Ireland have known about deaths and serious injuries and disabilities from these covid19 vaccines after January 2021. Yet they still inflict this harm on peoples and nations and certain vested interests with political connections to the government and NPHET and the CMO are profiteering from this. The criminal intent is clear here.
- Highly effective and safe medicines were blocked and banned by the government and NPHET and CMO in 2020 and 2021 but experimental vaccines which are mostly ineffective and quite dangerous were immediately legalized and promoted. But the latter create massive profits for certain vested interests with political connections to the government and NPHET and the CMO who are profiteering from this. The criminal intent is clear here.
- Over 1 million Irish people received the covid19 vaccines in 2021 but they did not give their informed consent as they were not fully informed about the risk of deaths and serious injuries and disabilities from these covid19 vaccines. This is against the Irish Constitution and EU and UN Human Rights laws and the Nuremberg Code. All of this was done for profit and for financial gains by those in political power and among government advisors. The criminal intent is clear here.
- **Profiteering from Coronaviruses:** Peter Daszak of the Eco Health Alliance has been a key player in the covid19 scandal. His organization received funding from the NIH in the USA and used it to fund gain of function research for coronaviruses and other viruses in the Wuhan lab in China. He played a major role in getting the general public and scientific community to believe that the covid19 virus was not manufactured in a lab. He has links to WHO, the NIH, the Wuhan lab and GAVI and worked closely with them in 2020 and 2021. This statement that was made by Peter Daszak in 2015, and reported in the National Academies of Press publication February 12th, 2016, provides an insight into him: **“We need to increase public understanding of the need for medical countermeasures such as a pan-coronavirus vaccine. A key driver is the media, and the economics will follow the hype. We need to use that hype to our advantage, to get to the real issues. Investors will respond if they see profit at the end of the process.”**

- Why were lies told about flus and colds and bacterial pneumonia in 2020 – lies stating that they mysteriously disappeared and were all replaced by covid19 ? and defective PCR tests used to mislabel colds and flu's as covid19 ?

- Nursing home deaths could have been avoided by government and state actions in 2020 but they refused to do so and this resulted in involuntary manslaughter in nursing homes. The elderly were cruelly and callously ignored at the time. This fed into the creation of more panic and fear being promoted by the government and their controlled press and media and the overall objective of massive financial gains to be made from such fear, panic and desperation.

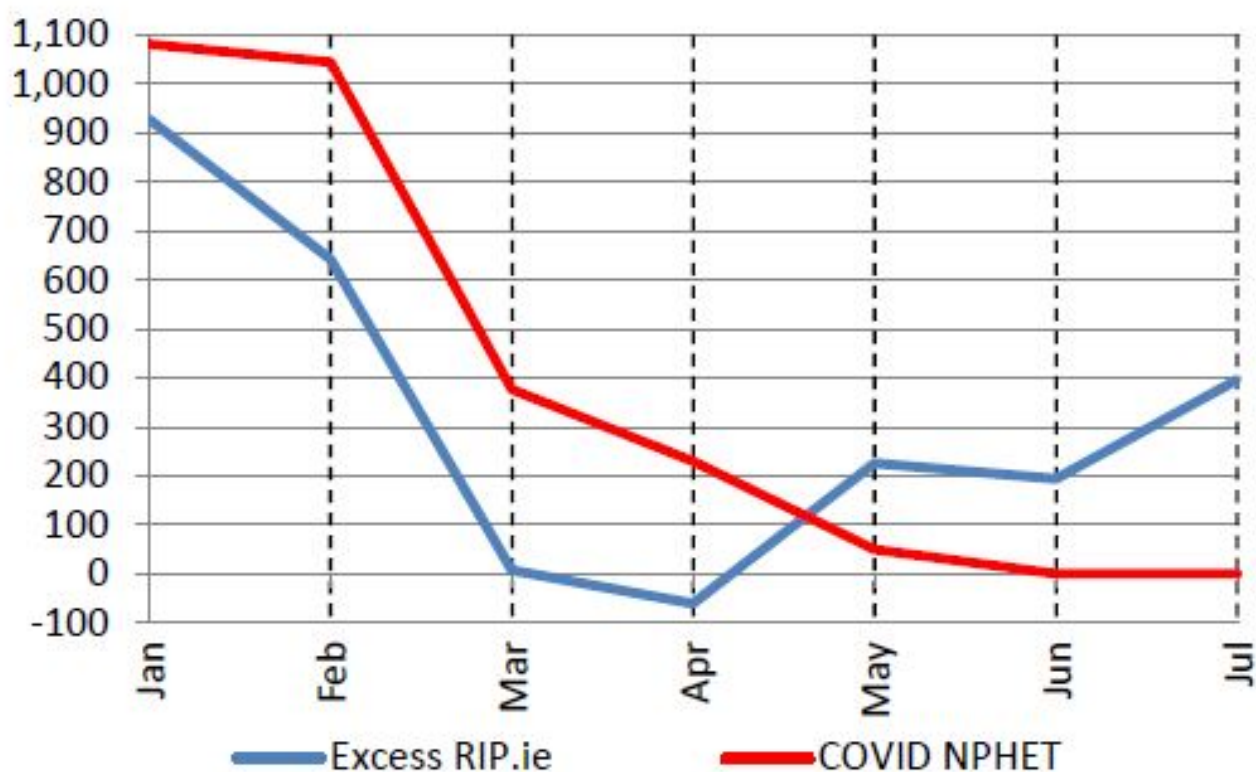
- We call on NPHEAT, Dr. Tony Holohan, the Minister for Health, the Taoiseach (Prime Minister) and RTE to produce evidence of the sars-cov2 virus also known as the covid19 virus including its isolation and purification and its full genome and transmission of this from person to person. If the evidence is not there and cannot be presented then this corroborates the **false statistics** charge against them in our original statement to gardai (Irish Police). If this evidence is not there and cannot be produced then we ask them to publicly state this to the Irish public and to immediately repeal and remove all laws and guidelines pertaining to covid19 including lockdowns, mandatory masks, promotion of covid19 vaccines and mandatory vaccine passports for accessing goods and services.
- We request Court Orders of Discovery in relation to the above matter and other matters detailed in the original statement to the Gardai on May7th 2021
- The number of covid19 variants caused by covid19 vaccines and ADE and other biological complications caused by these vaccines in Ireland and internationally.
- The number of covid19 vaccine injuries and disabilities and deaths mislabeled as covid19 or covid19 variants in Ireland.

- Nphet and CMO and government plans and statistics to wrongly blame the covid19 variants on the unvaccinated. And their plans for more lockdowns in 2021 and 2022 and to blame the unvaccinated.
- The number of covid19 variant infections and hospitalisations among the covid19 vaccinated and the unvaccinated. In many countries official statistics show that there are more covid19 infections and hospitalisations in the vaccinated.
- For the purpose of establishing the facts and accurate statistics about covid19, the conflicts of interest of NPHET members and Tony Holohan the CMO and his deputy Ronan Glynn and the HSE and Minister for Health and RTE and Dr. Luke O'Neill need to be fully investigated and detailed. ‘
