


Excess Mortality in Ireland and Britain after covid19 vaccines were introduced in January 2021. Murder / Manslaughter via Experimental vaccines.

Ireland Deaths 2021 rev.29/09/2021





- Excess Mortality from heart failure has increased in Britain in 2020 and this increase has been sustained into Summer and Autumn 2021. There are well documented scientific papers and research showing a link between covid vaccines and several heart diseases and that that these vaccines increase the risk of heart inflammation and diseases by many times. These are listed and detailed in the sections below. Excess Deaths from ages 25 to 49 also show a rise in 2021 with a spike after the introduction of the vaccines.


Weekly Excess Deaths by Date of Registration, Heart failure, England

- **Covid19 Vaccine kills 2 people for every 1 person it saves. And kills six 20 year olds for every one person saved. And statistical and scientific evidence from the USA points to 150,000 killed by the covid vaccine by September 2021.**

At an FDA Meeting about approval for covid19 vaccines and boosters on September 17, 2021, Mr. Steve Kirsch stated that new scientific research findings show that the covid19 vaccines kill 2 people for every 1 person it saves. And kills six 20 year olds for every one person saved. This is based on the absolute all cause mortality risk associated with these covid19 vaccines. Absolute all cause mortality risk is used for other medicines and vaccines and should have been used for the covid19 vaccines. He presented the scientific findings from around the world at this FDA meeting and has them available for the courts. This also includes a very high risk of myocarditis and other heart conditions for children. The VAERS system and other tracking system worldwide confirm that the covid19 vaccines cause a wide variety of injuries and new illnesses many of which lead to premature death. And many of these deaths are not being correctly labeled as “covid19 vaccine caused deaths”. There is evidence of massive under-reporting of covid19 vaccine deaths in the USA due to several factors including cover ups by hospitals and the fact that it takes over half an hour to file one report and the vaers computer system is often down. A Harvard Medical School study and paper concluded in 2010 that VAERS under-reported actual reports by a factor of 100 and deaths and serious injuries by a factor of 10. He provided statistical and scientific evidence from the USA which points to 150,000 people killed by the covid19 vaccine by September 2021. This evidence is available below.

His evidence is corroborated by the Harvard Medical School paper of 2010 and the WHO’s database of vaccine injuries, illnesses and deaths. The documentation attached to this document is from the VigiAccess system run by the WHO. I attach a small proportion of the side effects and injuries of the covid19 vaccine and its over 18 pages. The full listing of side effects and injuries is over 115 pages and can be downloaded at <https://www.data-analytica.org/side-effects.pdf> . Many of these illnesses and injuries on the list are very serious and can cause early death or premature death. This has serious implications for many countries including Ireland.

There is a need to correctly label “covid19 vaccine caused deaths” and “covid19 vaccine caused injuries or illnesses” - this is a massive challenge to health authorities and coroners worldwide

including the HSE and the HPRA and the coroners in Ireland. As these covid19 vaccines affect Ireland, this testimony to the FDA in the USA is relevant and important to Ireland and court cases here in Ireland.

- **Estimating Vaccine-Induced Mortality**

Matthew Crawford a well known statistician studied covid19 vaccine deaths in many countries and has estimated the fatality rate from covid19 vaccines as 411 people per million doses. If we limit to within 21 days of a vaccination

As you can see above 14,265 people died within 21 days of having the first dose of a Covid-19 vaccine, and 4,388 people died within 21 days of having the first dose of a Covid-19 vaccine whose death allegedly involved Covid-19. This involves covid19 deaths and non covid19 deaths

Another 11,470 people died within 21 days of having their second dose of having a Covid-19 vaccine, and 182 people died within 21 days of having their second dose of a Covid-19 vaccine whose death allegedly involved Covid-19.

Therefore a total of **30,305** people died within 21 days of having the Covid-19 vaccine in England during the first 6 months of 2021. A further **123,796** people died 21 days or more after having the Covid-19 vaccine.

There is a need to correctly label “covid19 vaccine caused deaths” - this is a massive challenge to health authorities and coroners worldwide including the HSE and the HPRA and the coroners in Ireland.



- **Absolute All Cause Mortality risk from covid19 vaccines and boosters**

There is a need for the FDA in USA and the HSE in Ireland and SAGE in Britain to measure Absolute All Cause Mortality Risk of covid19 vaccines and boosters

The absolute all cause mortality risk of the covid19 vaccines and boosters need to be measured by health authorities and governments in all countries. This is especially important given all the adverse effects including deaths from these vaccines - see <https://www.skirsch.com/covid/Deaths.pdf>

This is a table comparing the rate of adverse events this year relative to the annual VAERS incidence rate reported for all vaccines over the period from 2015-2019 for ages 20 to 60. We limited the age range to show that these events are affecting young people and not just the elderly. Also, the signal to noise ratio is much stronger in this younger age group since they are less likely to suffer "background" adverse events.

A value of 473 means the rate reported in VAERS for the COVID19 vaccines in 2021 was 473 times

higher than what is typical for all vaccines combined in the typical average year. Nearly all serious adverse events we looked at were strongly elevated compared to the expected normal baseline event rate. This table is useful when assessing whether the vaccine may have been involved in causing death in cases. The symptoms listed here are consistent with the presumed mechanism of action for how these vaccines kill people (producing spike protein throughout the body that cause inflammation, scarring, and blood clots). Surprisingly, only a few of these symptoms appear in the labelling of the recently approved Pfizer vaccine. Thus, this table is important and timely.







The Lack of or Absence of Informed Consent when giving the covid19 vaccines and boosters

The over crowded hospitals and medical clinics are continuing into Autumn and Winter 2021 as more people become afflicted by these side effects and injuries in addition to the new variants of covid19 among the vaccinated and unvaccinated and the many other illnesses and diseases and accidents.
