## Subject: TD's calling for an Independent Inquiry into High Excess Deaths in Ireland in 2023 and since 2021

In respect of recent calls by several TD's in Dail Eireann, on October 18th 2023, for an Independent Inquiry into the massive rise in Excess Deaths in Ireland in 2023 and since 2021, the following needs to be publicly stated and addressed in Dail Eireann. Official statistics from the GRO, the CSO, RIP.ie, Eurostat, Euromomo, and the OECD all show a high rise in excess deaths in Ireland since mid 2021 up to the present in 2023. These are official government and inter government bodies, not conspiracy theorists as falsely alleged by some people, including in Dail Eireann and in the press and media. This whole area of statistical and scientific debate has been tainted by false allegations of "conspiracy theories" and "conspiracy theorists" so as to shut down debate and proper official investigations and inquiries. While false accusations are made about so called "conspiracy theorists", many people are dying, including young people, who should not be dying. We don't need false accusers, liars, deceivers, and sneerers setting the agenda in Ireland and inside Dail Eireann. We need to restore, honesty, integrity and accountability in Dail Eireann and throughout Ireland. There is an upcoming Supreme Court case in Ireland where these official statistics from Ireland, the European Union and many other countries worldwide will be provided. This court case is predicated on the Constitutional and legal right and human right to full informed consent and application of the Precautionary Principle. This high excess death rate in Ireland since mid 2021 has been completely ignored and even denied by some TD's, Ministers and government and one should contrast this with the constant reporting of coivd19 deaths in the press and media, and in the Dail, and the panic and paranoia during the covid19 pandemic. Why is there such a massive difference between the two?

TD's are calling for an independent international inquiry into high excess deaths in Ireland since mid 2021. This needs to be implemented immediately. If it is blocked or refused, TD's can bring an

emergency High Court case with an an order of Mandamus, forcing the setting up of such an international inquiry. Its time to start implementing full accountability and use whatever means necessary to achieve accountability in Ireland.
