

Excess Mortality in Ireland by October 2021

This has been compiled by Kieran Morrissey who has presented statistics and statistical analysis for courts in the past. This excess mortality reached 2,356 excess deaths by October 2021. This uses the most up to date death statistics from RIP.ie . This rise occurred while hospital admissions for covid19 were very low. These excess deaths start with the introduction of covid19 vaccines in January 2021. Excess deaths for all of 2020 were 300. How did covid19 vaccines kill more people than covid19 ? is the **Absolute All Cause Mortality Risk** for covid19 vaccines being measured in Ireland ? is the **Absolute All Cause Mortality Risk** for Lockdowns and cancelled hospital appointments being measured in Ireland ? do they have the competence to do these measurements ? This **Absolute All Cause Mortality Risk** should also be categorised by age groups. See charts below.







Updated Statistics 31 October, 2021



Massive rise in nursing home deaths in January and February 2021 after covid vaccinations in them. This is very significant.

Excess Mortality up to 24 October 2021 in Ireland. Total Excess Mortality by end of October 2021 is 2,540 people and rising sharply. It is projected to rise to 4,000 people or more by the end of 2021. If the number of deaths become exponential in Winter due to many factors, the number could rise to more than 10,000. This is a National Emergency. By comparison, excess mortality for 2020, the year of the covid pandemic was 340 people.


We need an immediate investigation of the 2,540 excess deaths up to November 2021 to establish what is causing it and what role the covid vaccines are playing in this and what role the denial of safe and effective medicines for covid19 play in this. Also the role played by unlawful and illegal lockdowns which led to the cancellation of 200,000 hospital and clinic appointments for cancers, heart diseases, neurological diseases, respiratory diseases and other serious illnesses will need to be investigated. This has the characteristics of murder or manslaughter. We attach international evidence which corroborates these Irish findings.













Gibraltar is the most striking. Excess mortality was below zero and in minus figures until covid19 vaccinations began in February 2021. Then excess mortality suddenly increased sharply and has continued to rise in 2021. This is shocking. This is excellent evidence of the excess mortality associated with the covid19 vaccines. The figures for these countries show a sharp increase in excess mortality in 2021 after the introduction of covid19 vaccines in January or February 2021. There is a clear correlation between countries with high vaccination rates and rising or high excess mortality. All governments and health authorities should immediately implement **Absolute All Cause Mortality Risk measures for the covid19 vaccines** and Remdesivir and Midazolam (administered in nursing homes). And the **Absolute All Cause Mortality Risk for Lockdowns** in terms of thousands / millions of cancelled hospital appointments for serious diseases, and the increase in suicides and mental illnesses. And the **Absolute All Cause Mortality Risk for the safe and effective medicines – Ivermectin, Hydroxychloroquine, etc.** This **Absolute All Cause Mortality Risk and Excess Mortality** should be categorised by age groups.

In highly vaccinated countries, covid19 deaths are low in October 2021, yet excess mortality is rising. The correlation between covid19 vaccinations and excess mortality needs to be fully investigated and prioritised in all countries, including Ireland.



Science shows Covid19 Vaccines are ineffective and dangerous

- The government health authority in Britain, the PHE, has produced reports showing a collapse in the effectiveness of covid19 vaccines. - By mid September 2021, Waterford was the most highly covid vaccinated county in Ireland at 99% for adults. Waterford also had the highest rate of covid19 infections in mid October 2021. 

Covid19 cases rose sharply in all of these highly vaccinated countries from June 2021 up to the present, October 2021. It is highly unusual for a virus to spread during the Summer months. The rise in covid19 cases was much higher and more prolonged after vaccinations in January 2021 than in 2020 prior to vaccinations. 



In 2020, 316 million vaccinations were administered. There were only 3 million covid19 vaccinations administered in 2020. In 2021, 320 million vaccinations were administered and most of them were covid19 vaccinations. There was a massive rise in vaccine deaths in 2021 in the USA in 2021.




