**DAEN Australia** – the equivalent of the Yellow Card reporting system in Britain has logged (up to January 19th) 104,214 reports of adverse events, including 746 deaths.

### **Ireland, January 2022**

A total of **101 deaths and 18,108 injuries, illnesses and disabilities** have been reported to the Health Products Regulatory Authority (HPRA) up to January 2022, although it is to be noted these figures at best only capture a small fraction of the vaccine deaths and injuries. A Harvard Medical School Study in 2010 shows that the real figures for vaccine deaths and injuries may be 10 times higher.

Dr Peter McCullough, Dr Anthony Kyriakopoulos, Dr Greg Nigh, and Dr Stephenie Sennef conclude their study by calling attention to three very important aspects of the safety profile of the Covid-19 vaccines.

1. The extensively documented subversion of innate immunity, which they claim is and will continue to have a wide range of consequences including reduced ability to effectively combat future infections.

Prof. Kuhbandner of the University of Regensburg in Germany examined the mortality data for Britain and Germany in 2021 and found the very same pattern - large jumps in mortality immediately following the vaccine campaigns. **In Britain** on January 20th, the MHRA Yellow Card reporting system has recorded a total of 1,439,579 events based on 439,578 reports. The total number of fatalities reported is 1,972.

- Pfizer (25.6 million first doses, 22.5 million second doses) now has one Yellow Card in 159 people vaccinated. Deaths: 1 in 36,467 people vaccinated (702).
- AstraZeneca (24.9 million first doses, 24.2 million second doses) has one Yellow Card in 103 people vaccinated. Deaths: 1 in 20,750 people vaccinated (1,200).
- Moderna (1.6 million first doses, 1.4 million second doses) has one Yellow Card in 46 people vaccinated. Deaths: 1 in 48,485 people vaccinated (33).



Scotland: 20 Nov 21 - 07 Jan 22






### Number of Covid-19 Deaths by Vaccination Status






**Covid-19 Cases by Vaccination Status in England**  
**Week 51 2021 - Week 2 2022**





- **Evidence of Increased Infection Risk Following Third Dose Exacerbated by Vaccination Drive During Omicron Wave, UKHSA Data Show**












